# True North Commercial Real Estate Investment Trust Completes Second Acquisition in the Greater Toronto Area

TORONTO, Aug. 23, 2016 /CNW/ - True North Commercial Real Estate Investment Trust (the "**REIT**") (TSX: TNT.UN) is pleased to announce it has closed the acquisition of an office property located at 5900 Explorer Drive, Mississauga, Ontario (the "**Explorer Property**").

The property is a two-storey office building situated on 2.05 acres located in Mississauga's prestigious Airport Corporate Centre with a total of approximately 40,000 rentable square feet and 140 surface parking stalls and is well situated with excellent access to Highways 401, 427, 409 and 403 as well as being in close proximity to Pearson International Airport. Built in 2000, this modernly constructed office building is 100% occupied by a single tenant with a strong corporate covenant providing for long term stable cash flows.

The \$10.5 million purchase price for the Explorer Property was satisfied by: (a) approximately \$3.150 million cash from the previously announced private placement; and (b) \$7.350 million aggregate principal amount of new mortgage financing with a five-year term and a fixed rate of 2.65%.

The REIT is an unincorporated, open-ended real estate investment trust established under the laws of the Province of Ontario. The REIT currently owns and operates a portfolio of 27 commercial properties consisting of approximately 1.54 million square feet in secondary markets across Canada.
