

True North Commercial REIT Provides Update on Accretive Unit Repurchases under Normal Course Issuer Bid

TORONTO, ON – February 6, 2023 – True North Commercial Real Estate Investment Trust (TSX: TNT.UN) (the "**REIT**") is pleased to provide an update on its normal course issuer bid ("NCIB") announcing that it has repurchased 248,740 trust units ("Units") from January 1, 2024 to January 31, 2024, bringing the total number of Units repurchased since the start of the NCIB to 634,611 Units. The repurchase of Units under the NCIB continues to be accretive to the REIT's funds from operations per Unit ("FFO") and adjusted funds from operations per Unit ("AFFO"). There were no purchases made by insiders of the REIT during this period in compliance with the REIT's insider's trading policy that restricts purchases until 24 hours following the issuance of the 2023 year-end financial results which is currently scheduled to be released on Tuesday, March 19, 2024.

FFO and AFFO as computed by the REIT may not be comparable to similar measures presented by other issuers.
